



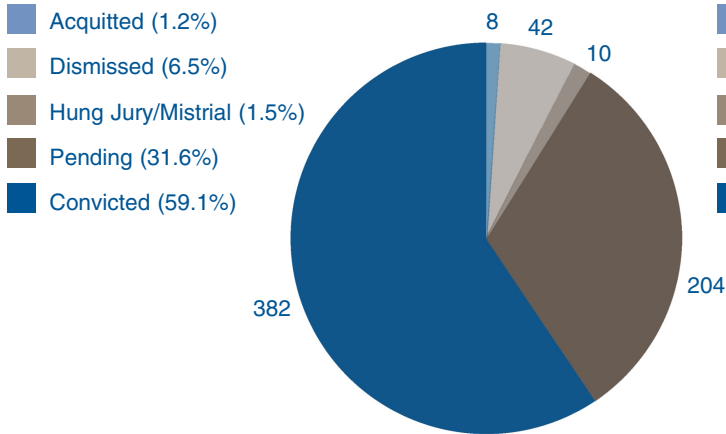

<p><sup>1</sup>"Terrorism" as used herein includes the four primary terrorism statutes: 18 U.S.C. 2332 (Terrorism), 18 U.S.C. 2339A (Material Support to Terrorists), 18 U.S.C. 2339B (Material Support to a Foreign Terrorist Organization), and 50 U.S.C. 1705 (Financial Support to a Foreign Terrorist Organization).</p> <p><sup>2</sup>Trials are counted per defendant. A trial with three co-defendants, for example, counts as three trials. If the same person is tried in two separate proceedings under two separate indictments, the trials are counted separately.</p> <p><sup>3</sup>Defendants convicted on terror charges may also have been convicted on other charges.</p> <p><sup>4</sup>Four people were acquitted of all federal terrorism charges but convicted of other crimes.</p>		

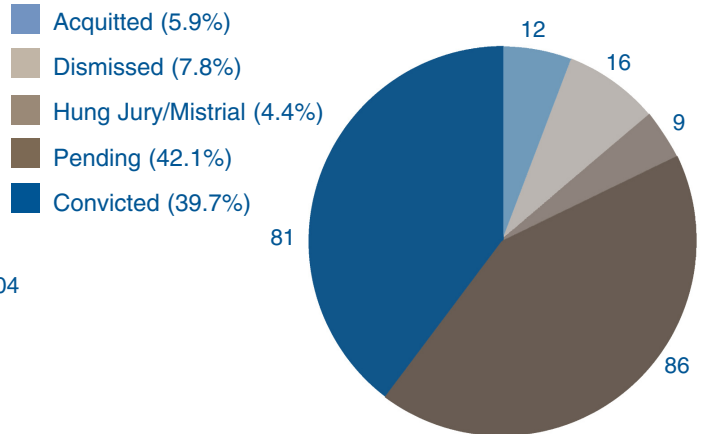
